Findlay Country Club and *Lakeview Pool & Tennis Club* will again have a combined swim team to participate in the BSSL league. Swim meets will be held on Wednesday evenings in June and July. Full schedule to be posted on the web site, just as soon as it is confirmed.

Practices will be held Monday – Friday, morning times to be posted on the web site as soon as they are confirmed.

A child must be able to swim a lap of the pool by him/herself to be on the swim team. A swimmer must attend a minimum of two practices prior to swim meet to guarantee they will be swimming. Swimmers who consistently attend practice will have first choice on their events. Swimmers who miss too many practices can still swim at the meets, although they will not be guaranteed all the events they desire.

Parents are needed as timers, scorers, in the bullpen, etc. All parents are expected to volunteer to help run the meets, and your help is greatly appreciated!
